**ORDINANCE NO. 2603**

**AN ORDINANCE AMENDING CHAPTER II, SECTION 2-40.1  
OF THE CODE OF THE BOROUGH OF ROSELLE PARK,  
ENTITLED, "ROSELLE PARK ARTS COMMITTEE CREATED"**

**WHEREAS**, after deliberation and consultation with the membership of the Arts Committee the governing body finds it necessary and appropriate to update and thereby amend the Municipal Code so to reflect a revised membership total for the Arts Committee.

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Council of the Borough of Roselle Park, County of Union and State of New Jersey that Chapter II of the Code of the Borough of Roselle Park be and hereby is amended as follows:

**SECTION 1.** Amendment(s) to Arts Committee Membership

2-40.1 Roselle Park Arts Committee Created.

- a. There is hereby established within the Borough of Roselle Park the Roselle Park Arts Committee.
- b. The purpose of the Roselle Park Arts Committee shall be to encourage the arts in the Borough of Roselle Park. The Committee may make recommendations to the Mayor and Council about art plans and may suggest to the Mayor and Council methods to improve dissemination of information to residents to increase participation in art events in the Borough.
- c. The Roselle Park Arts Committee shall consist of ~~twelve (12)~~ **seven (7)** members. All appointments to the Roselle Park Arts Committee shall be made by the Mayor. Each appointment shall be for a term of one (1) year, which expires on December 31 of that year. The Mayor shall have the authority to remove any member of the Roselle Park Arts Committee, at any time.
- d. The Roselle Park Borough Council shall appoint one of its members to be a liaison to the Roselle Park Arts Committee for a term of one (1) year, which expires on December 31 of that year.

**SECTION 2.** Invalidity

If any section or portion of a section of this Code shall be invalid for any reason, such invalidity shall not affect the validity of the remaining sections or portions of this Ordinance.

**SECTION 3.** Inconsistent Ordinances Repealed.

All Ordinances or parts of Ordinances, to the extent that they are inconsistent herewith, are hereby repealed.

**SECTION 4.** Captions.

Captions contained in this Ordinance have been included only for the purpose of facilitating reference to the various sections and are not intended and shall not be utilized to construe the intent and


meaning of the text of any section. Likewise, all strike through text ~~thus~~ should be considered a deletion from Borough Code, and all bolded text **thus** should be considered an addition to Borough Code.


**SECTION 5.** Effective Date.
