REGULATED USES OF TEMPORARY STORAGE TRAILERS (PODS)

- NO TOXIC OR VOLITALE MATERIALS WILL BE STORED IN SAME
- TRAILERS/PODS WILL BE PLACED ON APPLICANTS PROPERTY IN A FASHION AS NOT TO INTERFERE WITH PUBLIC RIGHT-OF-WAY. (SIDEWALKS AND STREETS)
- UNDER NO CIRCUMSTANCES SHALL TRAILERS/PODS REMAIN ON PROPERTIES IN EXCESS OF SIX (6) MONTHS.
- ONLY ONE PERMIT PLUS TWO (2) RENEWAL PERIODS WILL BE PERMITTED PER PROPERTY OVER A PERIOD OF TWO (2) YEARS.
- THE PERMIT WILL BE VALID FOR A PERIOD OF TWO (2) MONTHS AND CAN BE RENEWED FOR ONE (1) ADDITIONAL PERIOD OF TWO (2) MONTHS FOR AN ADDITIONAL FEE AND THAN FOR A THIRD AND FINAL TWO (2) MONTHS FOR AN ADDITIONAL FEE (REFER TO FEE SCHEDULE)
- PERIODIC INSPECTIONS BY A CONSTRUCTION DEPARTMENT REPRESENTATIVE TO ENSURE THAT ABOVE REQUIREMENTS ARE MET.

FEE SCHEDULE

INITIAL FEE \$50.00 FOR TWO (2) MONTHS
\$100.00 ADDITIONAL TWO (2) MONTHS
\$150.00 ADDITIONAL TWO (2) AND FINAL MONTHS

PENALTIES FOR VIOLATIONS

- FIRST OFFENSE OF NO LESS THAN \$500.00, NO GREATER THAN \$750.00
- SECOND OFFENSE NO LESS THAN \$1000.00, NO GREATER THAN \$1200.00
- THIRD OR SUBSEQUENT OFFENSE NO LESS THAN \$1500.00, NO GREATER THAN \$2000.00
- IN ADDITION TO THE ABOVE FINES, THERE WILL BE AN ADDITIONAL FINE OF \$100.00 PER DAY FOLLOWING A CONVICTION FOR THE VIOLATION OF THIS ORDINANCE. FOR EACH DAY THAT THE TRAILER/PODS STORAGE CONTAINER REMAINS ON THE PREMISIS IN QUESTION.
