

# AMENDMENT TO SHARED SERVICES AGREEMENT FOR EMS BETWEEN THE COUNTY OF UNION AND THE BOROUGH OF ROSELLE PARK

This Amendment to Agreement is entered into this 3<sup>rd</sup> day of August, 2017, by and between the **COUNTY OF UNION**, a Body Politic of the State of New Jersey, having its principal place of business located at Union County Administration Building, 10 Elizabethtown Plaza, Elizabeth, New Jersey, 07207 (hereinafter referred to as the "COUNTY"), and the **BOROUGH OF ROSELLE PARK**, a municipal corporation of the State of New Jersey (hereinafter referred to as the "BOROUGH"), having its principal office at Roselle Park Borough Hall, 110 East Westfield Avenue, Roselle Park, New Jersey 07204.

**WHEREAS**, pursuant to Resolution No. 2015-602, the COUNTY entered into an Agreement with the BOROUGH dated August 1, 2015, to provide emergency medical services for the BOROUGH (hereinafter referred to as the "Agreement"); and

**WHEREAS**, pursuant to Resolution No. 2017-558, it was necessary to amend Resolution No. 2015-602 to extend the Agreement's contract period through April 30, 2022 and to amend certain terms of the Agreement; and

**NOW, THEREFORE**, in consideration of the foregoing and the mutual promises in the Agreement and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties do agree to amend the Agreement as follows:

The COUNTY and BOROUGH agree to extend the Agreement's contract period through April 30, 2022 for the continued provision of emergency medical services ("EMS").

The COUNTY and the BOROUGH agree that EMS coverage shall be provided by the COUNTY to the BOROUGH for twenty-four (24) hours, seven (7) days a week, every day of the year including special events if necessary.

The BOROUGH agrees to transfer ownership of three (3) current BOROUGH-owned ambulances to the COUNTY at no cost to the COUNTY except for the COUNTY's obligation relative to the licensing and obtaining proper insurance coverage of the vehicles.

The BOROUGH agrees to permit the COUNTY to utilize the BOROUGH-owned building and property located at 535 Laurel Avenue, Roselle Park, NJ, 07204.

If applicable, any extension of the original term of this Agreement shall be subject to the annual availability and appropriation of sufficient funds by the COUNTY pursuant to N.J.S.A. §40A:11-15.

A copy of this Amendment shall be filed with the Division of Local Government Services in the New Jersey Department of Community Affairs pursuant to N.J.S.A. 40A:65-4(b).

In all other respects the Agreement remains the same. The BOROUGH must ensure that all documents required in the original Agreement remain updated to reflect the new terms and remain in effect for the duration of this Amendment. In case of conflict between any of the provisions of this Amendment, another Amendment, or this Agreement, the provisions of this Amendment shall control.


