The Borough of Roselle Park intends to participate in the Sourcewell National Cooperative Purchasing System for Contract No. 012418-TER to purchase a Freightliner XT Pro 70 Inline Forestry Elevator.

The Borough of Roselle Park joined the National Joint Powers Alliance Cooperative Purchasing System on December 21, 2017 which was then reorganized and succeeded by the Sourcewell National Cooperative Purchasing System; and, in addition, the Borough of Roselle Park anticipates participating in Sourcewell National Cooperative Purchasing System Contract No. 012418-TER on March 5, 2020, with a contract delivery term of ten (10) to twelve (12) weeks.

It is the intent of the Borough of Roselle Park to make a contract award to Custom Truck One Source of 12660 East Lynchburg Salem Turnpike, Forest, Virginia 24551 as the authorized dealer/distributor for Terex Utilities, Inc. pursuant to the proposal submitted by Terex Utilities, Inc. in response to the Sourcewell National Cooperative Purchasing System's request for proposals.

The Borough of Roselle Park is permitted to join national cooperative purchasing agreements under the authority of N.J.S.A. 52:34-6.2(b)(3).
